

Please sign, date and return one copy of this Agreement to confirm you have complied with/will comply with the following criteria and conditions:

1. I am/will become a paid-up Junior member of Squash Wales and a member of the Academy Squad for which I am selected.
2. I have/will sign and return the Squash Wales Code of Conduct and Commitment Form and one copy of this Agreement Form and **pay the £60 National squad fee.**
3. I will attend all of the National Squads that I am invited to for the 2018/2019. I understand that my selection for a National Squad will depend on my performance and attitude over 2018/2019 and I understand that I may **not** be invited to attend all National Squads in my age group.
4. If I am invited to attend a National Squad I understand that I must complete a Training Diary and submit it to my High Performance Coach at the end of every month. If you are not invited to future National Squads you will still be expected to complete a Training Diary.
5. Squash Wales would like (where practical) all injured players to attend National Squads, please confirm with your National Squad coach prior to attending. If I am not able to attend a National Squad I will complete an Exception Request Form with the reason why I will not be there and forward it to the appropriate High-Performance Coach or the Squash Wales office at least 1 week before the date of the Squad. Once a reason for non-attendance has been submitted it will be discussed by the Coaches Panel who will make a decision regarding whether or not the reason is acceptable. You will be notified of the outcome by your High Performance Coach.

If I am not able to attend a Squad due to illness or injury I will obtain a medical certificate and forward it to the Squash Wales office, no later than 5 days after the Squad.

6. I understand that National Squads take precedence over all other squash related events including all tournaments and the English Inter-County Championships.
7. I have read and understood the Junior National Squad Information Sheet, the terms and conditions of which form part of this Agreement.
8. Beds will be provided for every player and **one parent** who live more than 60 miles from the National Squad venue for Saturday night of the Squad.
9. Players/Parents are responsible for food and travelling to and from National Squads.

NOTE: The first point of contact for all queries relating to performance, National Squads and selection matters is the relevant High Performance Coach. If the High Performance Coach is unable to deal with an issue to the satisfaction of all parties the matter will be referred to the Director of Coaching & Development.

Players may lose their eligibility for National Selection and may not be invited to future Squads if they do not attend a National squad to which they have been formally invited and they do not have a valid reason for non-attendance that has been ratified by the Coaches Panel.

Your compliance with the criteria listed in points 1 to 7 above will be monitored and your failure to comply with these criteria and conditions, and those contained in the Code of Conduct & Commitment, may result in your removal from the National Squad and the Academy Programme. If you are excluded you will be notified of this, together with the reason(s) for your exclusion, by the Director of Coaching & Development. If you are excluded you will not be eligible for selection for National Honours for your relevant age group.
